



ART OFFICIAL RULES AND GUIDELINES

1. **NO PURCHASE NECESSARY TO ENTER OR WIN.** Void where prohibited, taxed or otherwise restricted by law. All Federal, State and Local laws and regulations apply. Read all of the contest rules. Entries that do not adhere strictly to these rules and guidelines will not be judged. (See eligibility restrictions below.)

2. **Eligibility Restrictions:**

a. The art contest (the "Art Contest") is open to legal U.S. private and public school students who currently reside in the following states: CT, RI, MA, ME, NY, NH and NJ (the "Stop & Shop Arena") and DE, MD, VA and the District of Columbia (the "Giant Arena"), (collectively, the "Contest Arena"), who meet the following criteria: (i) entrants must reside in the Contest Arena; (ii) entrants must be currently enrolled as an elementary school student in a private or public school system (grades K through 5, depending on location); and (iii) entrants may not be the immediate family, e.g., spouses, children, siblings, parents, and/or IRS dependents, or household members, whether or not related) of employees, officers or directors of The Stop & Shop Supermarket Company LLC or Giant of Maryland LLC (collectively, the "Sponsors"), or their respective parent companies, subsidiaries or affiliates, advertising agencies, participating sponsors/promotional partners, judging or fulfillment agencies, and dealers.

b. To participate, entrants must depict in a drawing/painting how your school could use the A+ BonusBucksSM points they earn as described below. Print student's first name and grade level, school name/address/telephone number on **the back of the entry**. Entry must be on standard white 8 ½" x 11" paper (no photographs). The paper on which all entries are submitted shall become the property of the Sponsors, and no submissions will be acknowledged or returned. The copyright to the drawing/painting remains the exclusive property of the entrant. d. Each student may enter only one (1) drawing/painting.

4. Selection of Winners:

b. Five (5) finalists will be selected from grades K–2 and five (5) finalists will be selected from grades 3–5. Winning drawings/paintings will be announced on or about 03/02/10.

c. At all levels of judging, submissions that adhere to the guidelines will be judged with special attention to: (1) Expression of theme as it relates to the Contest and (2) Originality of drawing/painting or theme. Entries will be judged anonymously and will not be returned to students.

d. Limit one prize per family/household. Sponsors reserve the right not to award a prize or any prizes when submissions do not meet contest standards or criteria.

e. Sponsors will notify the potential winners via U.S. mail and/or overnight courier on or around 03/02/2010 and winners must accept prize within ten (10) days. The parents or legal guardians of potential winners must execute and return an Affidavit of Eligibility/Release of Liability Prize Acceptance Form within ten (10) days of notification attempt or prize will be forfeited and an alternate winner may be selected from the remaining eligible entries. If prize notification is returned as undeliverable or winner cannot be located or does not respond by deadline date, an alternate winner will be chosen and prize will be awarded.
